4	5. Paragraph 8 of the Golob Declaration: The best evidence rule prohibits establishing the

contents of a writing other than through the writing itself without establishing that the writing has been destroyed or is unavailable. Evidence Code Sections 1500-1501; *Von Briner v. Whirlpool Corp.* (N.D. Cal. 1973) 362 F.Supp. 1182). The declaration fails to do so yet seeks to establish the contents of a writing through a purported witness recollection, and this paragraph should be stricken.

9 6. Paragraph 9 of the Golob Declaration: Objection as the statement about what Golob's
10 friends purportedly told him is inadmissible hearsay and conclusory. Evidence Code Section
11 1200.

Paragraph 10 of the Golob Declaration: Objection as the statement lacks foundation as
not stating what dictionary is being quoted, is an improper opinion statement, and is irrelevant.
Evidence Code Sections 350, 800.
