- 4. On November 26, 2019, a minute order was issued from chambers continuing the Case Management Conference to March 5, 2020 at 3:30 p.m. in Department 402.
- 5. Our office received the minute order of November 26, 2019 in the first week of December 2019. At that time, the attorney handling the matter was transitioning to a new position as house counsel for a local company, and my secretary had resigned from my law firm. Due to these changes in personnel, the March 5, 2020 Case Management Conference did not get placed on my calendar.
